

# ECSC Travel Grant Program

## **1. Details of program**

### **Motion for the Establishment of an ECSC Travel Grant Program**

ECSC will, on a yearly basis budget monies towards a competitive travel grant program for use towards registration and attending the ECSC conference. Amount of budgeted funds will be decided at the ECSC Board Meeting of the prior year. Grant applications will be accepted by November 15th the semester prior to the conference using the application template provided on the ECSC web-page. A travel grant sub- committee will evaluate all applications and will announce: full, partial, or non-funding to all the applicants prior to December 15th of the same year of submission. The funds will be distributed within a month of the conference if the applicant institute has indeed attended the conference.

### **Motion to establish a Travel Grant Sub-Committee**

ECSC will establish a standing Travel Grant Sub-Committee which will be responsible for the evaluation of the Travel Grant Application template, selection from the submitted applications, notification of funding to applicants, and delivery of a report to the ECSC Board at the yearly meeting. The Sub- Committee will be populated by five ECSC Board Members with no two Sub-Committee members being from the same institute, and the five respective institutes becoming ineligible for applying. The Sub- Committee will be responsible for developing their own policies and procedures, evaluation rubric, etc., as well as electing the Chair of the Sub-Committee. The Travel Grant Sub-Committee members will serve three-year terms, with one re-election possible. For the inaugural Travel Grant Sub-Committee, three members will have a 3-year term and two will have a 2-year term to ensure that as the years pass, there is a balance between new perspectives of recently-elected members and the experience of returning members.

## **2. History of progress of the proposed program**

In an effort to encourage participation in the Eastern Colleges Science Conference (ECSC) at a time when budgets are being tightened, the ECSC Travel Grant Program Formation Committee was created during the April 18, 2015 board meeting. The committee was charged with developing a formal set of application and selection procedures needed to implement a travel grant program funded by ECSC. The committee members included:

Professor M. Anthony Kapolka (Wilkes University, new ECSC board member)

Professor Barbara Murdoch (Eastern Connecticut State University, new ECSC board member)

Professor Brian Palestis (Wagner College)

Professor Ronny Priefer (Western New England University, committee chair)

May 8, 2015, the committee submitted the proposal to the board for its consideration. The proposal consisted of five motions and a travel grant application form. Board members were asked to consider the proposal as a single package and to respond by June 1st. breakdown was as follows:

**Approved: 21 votes**

Of a total of 31 ECSC board members, the vote:

**Not Approved: 1 vote**

**Requires More Discussion: 2 votes**

**Nonrespondents: 7**

**With 21 of 31 possible votes choosing to approve, the proposal has been officially approved by the ECSC board.**

The ECSC Travel Grant Program Formation Committee now has approval to proceed with the formal establishment of the five-person Travel Grant Program Committee and implementation of the program.

## **Report from the Travel Grant Program:**

Don Stearns relayed the following report from Ronny Priefer, Chair of the Travel Grant Program: John Carroll University and Central Connecticut State University received travel grant awards for the ECSC 2019 of \$1,000 each. For review, there are three current members: Anthony Kapolka (term ends spring, 2020), Walter Steiner (term ends spring, 2020), and Ronny Priefer (term ends spring, 2021). The original approval of this committee stated that no member may serve more than two consecutive terms but can rejoin after a minimum one-year break. David Zuckerman was elected to a three-year term in July 2020. The Board needs to add a second member with a two-year term.
